

13th sitting of the Sejm, 25–27 April 2012

THE SEJM PASSED THE ACTS

- amending the act on the external trade of products, technologies and services of strategic importance for the safety of the state and for the maintenance of international peace and security, as well as amending some related acts;
- ratifying the Agreement between the Republic of Poland and Jersey for the exchange of information relating to tax matters, drawn up in London on 2 December 2011;
- ratifying the Agreement between the Republic of Poland and Jersey for the avoidance of double taxation with respect to enterprises operating ships or aircraft in international traffic, drawn up in London on 2 December 2011;
- ratifying the Agreement between the Republic of Poland and Jersey for the avoidance of double taxation on individuals, drawn up in London on 2 December 2011;
- ratifying the Agreement between the Republic of Poland and Baliwat Guernsey for the exchange of information relating to tax matters, drawn up in London on 6 December 2011.

THE SEJM ADOPTED RESOLUTIONS

- on supporting the Government of the Republic of Poland and summoning the European Parliament to actively pursue the simplification of the common agricultural policy, competitiveness and progress, as well as the introduction of equal and non-discriminating principles of the division of funds for direct farming subsidies between the Member States of the European Union;
- concerning the appointment and election of the personal composition of the Special Committee to consider particular bills relating to social security.

THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- amending the act on supporting the family and on the system of foster care, as well as amending some related acts;
- amending the Aliens Act and the act on promotion of employment and the labour market institutions.

THE SEJM REFERRED TO COMMITTEES

- Government bill amending the act on retirement pay and social benefits financed out of Social Insurance Fund and some related acts;
- Government bill amending the act on retirement pensions of professional soldiers and their families, the act on retirement pensions of the officials of the Police, the Internal Security Agency, the Intelligence Agency, the Military Counterintelligence Service, the Military Intelligence Service, the Central Anticorruption Bureau, the Border Guard, the Government Protection

- Bureau, the State Fire Service, the Prison Service and their families, as well as amending some related acts;
- Senate's bill amending the Penal Code and the act on the system of social insurance;
- Senate's bill amending the Code of Penal Procedure;
- Deputies' bill amending the Telecommunications Law;
- Deputies' bill amending the act on the commune government.

THE SEJM REJECTED IN THE FIRST READING

the Deputies' bill on taxation of particular financial institutions.

THE SEJM ACCEPTED the information of the Council of Ministers on realisation of tasks resulting from the National Drug Use Prevention Programme in 2010 (*The Sejm considered the document at the 12th sitting*).

THE SEJM CONSIDERED „The report on the realisation of the national cancerous disease counteraction programme in 2010” presented by the Minister of Health, and the Schedule for tasks being realised as regards the long-term “National neoplastic disease counteraction programme” in 2011 adopted by the Council of Ministers, along with the directions for the realisation of the programme in 2012 and 2013 (*The motion to reject the information shall be subject to a vote at the next sitting of the Sejm*).

THE SEJM CONSIDERED THE CURRENT INFORMATION on the shortage of oncological medications – citostatic drugs – and the cases of therapy suspension related thereto.
