# 15<sup>th</sup> sitting of the Sejm, 23–25 MAY 2012

# THE SEJM PASSED THE ACTS

- amending the act on the turnover of financial instruments and the act on public offer and terms for introducing financial instruments into the organized turnover system and on public companies;
- amending the act on disclosing in real-estate registers the right of property of the State Treasury and local government units;
- amending the act on the organisation of the fish market;
- amending the act on spirit drinks production and on the registration and protection of geographical designations of spirit drinks;
- amending the act on passport documents;
- ratifying the European Agreement relating to Persons Participating in Proceedings of the European Court of Human Rights of 5 March 1996;
- ratifying the Protocol on Pollutant Release and Transfer Registers to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters, drawn up in Kiev on 21 May 2003.

# THE SEJM ADOPTED RESOLUTIONS

- on removing discordances from the act of 5 November 2009 on co-operative savings and credit unions;
- commemorating the 75th anniversary of initiating the development of the Central Industrial Region (COP);
- considering changes within personal composition of the Sejm committees;
- considering the election of the new personal composition of the European Union Affairs' Committee.

# THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- amending the act on execution of penalty of detention in the form of electronic monitoring beyond the limits of a penal institution;
- amending the act on the external trade of products, technologies and services of strategic importance for the safety of the state and for the maintenance of international peace and security, as well as amending some related acts.

# THE SEJM REFERRED TO COMMITTEES

- Government bill amending the Road Traffic Act and some related acts;
- Deputies' bill on the remission of dues in the form of unpaid social security fees incurred by persons conducting non-agricultural business activity;
- Deputies' bill amending the Code of Penal Procedure, the act on Public Prosecutor's Office and the act on the system of common courts;
- Deputies' bill amending the Penal Code;
- Deputies' bill amending the Penal Code;
- Deputies' bill amending the Penal Code;
- Deputies bill on political foundations.

#### THE SEJM CONSIDERED

- National Spatial Development Concept 2030 submitted by the Prime Minister, and the Committee's opinion related thereto (*The motion to reject the document shall be subject to a vote at the next sitting of the Sejm*);
- report on realisation of EURO 2012 undertakings and tasks realised as regards Poland's preparation for the European Football Championship UEFA EURO 2012<sup>™</sup> Final Tournament (March 2011–January 2012) submitted by the Council of Ministers, and the Committee's opinion related thereto (*The motion to reject the report shall be subject to a vote at the next sitting of the Sejm*).

#### THE SEJM CONSIDERED THE CURRENT IN-

**FORMATION** on the strategy of withdrawing Polish troops from Afghanistan.

### THE SEJM REJECTED IN THE SECOND READING

the Deputies' draft resolution considering the policy of the Republic of Poland as regards the European Union crisis.

# THE SEJM REJECTED IN THE FIRST READING

- Deputies' bill on transferring by employers of the means to finance expenses related to the employees' health protection (personal health protection accounts) and some related acts;
- Deputies' bill amending the Electoral Code and some related acts.

**THE SEJM DID NOT ACCEPT** the motion for a vote of no confidence in the Minister of National Education Krystyna Szumilas.
