

## 22<sup>nd</sup> sitting of the Sejm, 26–28 September 2012

### THE SEJM ADOPTED RESOLUTIONS

- honouring the 90<sup>th</sup> anniversary of initiating the construction of the sea port in Gdynia;
- honouring the 20<sup>th</sup> anniversary of establishing diplomatic relations between the Republic of Poland and the Republic of Moldova.

### THE SEJM CONSIDERED IN THE SECOND READING

- the Deputies' bill amending the act on passport documents;
- Government bill amending the act on the organisation of fruit and vegetable market, hops market, dried feed market as well as flax and hemp grown for fibre markets;
- Committee bill amending the act on corporate savings and loan associations;
- Deputies' bills amending the Broadcasting Act (*prints no. 640, 641*);
- Government bill ratifying the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on their Destruction, drawn up in Oslo on 18 September 1997;
- Government bill on the revised scope of the Convention on the Rights of the Child adopted on 20 November 1989 in New York;
- Government bill on the revised scope of the Optional Protocol to the Convention on the Rights of the Child on the Involvement of Children in armed conflict adopted on 25 May 2000 in New York;
- Government bill ratifying the Agreement between the Republic of Poland and Ukraine on social security drawn up in Kiev on 18 May 2012;
- Government bill ratifying the Protocol between the Republic of Poland and the Grand Duchy of Luxembourg amending the Convention between the Republic of Poland and the Grand Duchy of Luxembourg for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income and on capital, drawn up in Luxembourg on 14 June 1995, signed in Luxembourg on 7 June 2012;
- Government bill ratifying the Convention between the Republic of Poland and Canada for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income, and the Protocol, signed in Ottawa on 14 May 2012;
- Government bill ratifying the Protocol between the Government of the Republic of Poland and the Government of the Republic of Iceland amending the Agreement between the Government of the Republic of Poland and the Government of the Republic of Iceland for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income and on capital, drawn up in Reykjavik on 19 June 1998, signed in Reykjavik on 16 May 2012;

- Committee draft resolution considering the Proposal for a Regulation of the European Parliament and of the Council on clinical trials on medicinal products for human use, and repealing Directive 2001/20/EC inconsistent with the principle of subsidiarity. (*The third readings of the listed bills and the voting on the draft resolution shall be held at the next sitting of the Sejm.*)

### THE SEJM CONSIDERED IN THE SECOND READING AND RETURNED TO COMMITTEES

- Government bill amending the act on personal income tax;
- Government bill amending the Road Traffic Act and some related acts;
- Government bill amending the Broadcasting Act.

### THE SEJM RETURNED TO THE COMMITTEE

the Committee draft resolution on the rational implementation of the climate policy.

### THE SEJM CONSIDERED IN THE FIRST READING AND REFERRED TO THE COMMITTEE

the Deputies' bill amending the Labour Code.

### THE SEJM CONSIDERED IN THE FIRST READING

- Deputies' bill on the planned parenthood;
- Deputies' bill amending the act on family planning, protection of human embryo and the conditions for admissibility of pregnancy termination;
- Deputies' bill on the Commissioner for Taxpayers' Rights. (*Motions to reject the bills shall be considered at the next sitting of the Sejm.*)

### THE SEJM CONSIDERED

- information of the Minister of Justice on actions undertaken by the Ministry of Justice and entities subjected thereto and supervised thereby with respect to guaranteeing the proper procedures as regards handling the bodies of the victims of the Smolensk Catastrophe within the territory of the Russian Federation;
- information of the Minister of Environment "Water management in Poland in the years 2010–2011". (*Motions to reject the information shall be held at the next sitting of the Sejm.*)

### THE SEJM CONSIDERED THE CURRENT INFORMATION

on the state of realisation of the railway safety package.
