



## 41<sup>st</sup> sitting of the Sejm, 10–11 May 2017

### Considered in the first reading

- the Government's bill amending the act on animal protection and the Penal Code (referred to Agriculture and Rural Development Committee and Justice and Human Rights Committee);
- the Government's bill amending the act on employment promotion and labour market institutions and some related acts (Marshal of the Sejm postponed the vote on referring the bill to a committee to the next sitting of the Sejm);
- the Deputies' bill amending the Code of Administrative Procedure (the motion to reject the bill in the first reading shall be subject to a vote at the next sitting of the Sejm);
- the Deputies' bill amending the Labour Code (the motion to reject the bill in the first reading shall be subject to a vote at the next sitting of the Sejm);
- the Deputies' bill amending the act on the commune government and some related acts (the motion to reject the bill in the first reading shall be subject to a vote at the next sitting of the Sejm).

### Considered in the second reading

- the Government's bill amending the act on the financing of the common agricultural policy;
- the Committee's bill amending the act on the agricultural tax and the act on local taxes and fees;
- the Government's bill amending the act on health care benefits financed out of public funds and some related acts (amendments have been submitted, the Sejm returned the bill to Health Committee);
- the Government's bill amending the Geological and Mining Law and some related acts (amendments have been submitted, the Sejm returned the bill to Energy and State Treasury Committee and Environment Protection, Natural Resources and Forestry Committee);
- the Deputies' bill amending the act on local government employees (the motion to reject the bill submitted by

Administration and Interior Affairs Committee and Territorial Government and Regional Policy Committee shall be subject to a vote at the next sitting of the Sejm).

### Passed acts

- amending the act on the National School of the Judiciary and Prosecution Service, the Law on the System of Common Courts and some related acts;
- amending the act on retirement pensions of the officials of the Police, the Internal Security Agency, the Intelligence Agency, the Military Counterintelligence Service, the Military Intelligence Service, the Central Anticorruption Bureau, the Border Guard, the Government Protection Bureau, the State Fire Service, the Prison Service and their families, as well as amending some related acts.

### Considered resolutions of the Senate concerning the acts

- amending the act on environment protection (the Senate's amendments were accepted);
- on auditors, audit companies and on public supervision (some of the Senate's amendments were accepted);
- amending the act on the system of social insurance and the act which itself amended the Labour Code and some related acts (the Senate's amendments were accepted).

### Adopted resolutions

- on considering the proposal for the directive of the European Parliament and of the Council on the internal market for electricity (modified version) inconsistent with the principle of subsidiarity;
- on the 40<sup>th</sup> anniversary of the foundation of the Student Committee of Solidarity (*Studencki Komitet Solidarności*) in Krakow.

### Government's current information

- concerning the new draft regulation of the Ministry of National Education on resigning from individual education in kindergartens and schools.
