

39th sitting of the Sejm, 8–10 MAY 2013

THE SEJM PASSED THE ACTS

- amending the act on custody over children below three years of age and some related acts;
- amending the act on the annual extra salary for the employees of the budget sphere units;
- amending the Penal Code and the Code of Penal Procedure;
- amending the Code of Penal Procedure and the Petty Offences Procedure Code;
- amending the act on the system of common courts;
- on the management of packaging and packaging waste;
- annulling the act on ownership transfer of the LOT Polish Airlines state enterprise;
- amending the Press Law.

THE SEJM ADOPTED RESOLUTIONS

- concerning participation of the Republic of Poland in the works of the European Union in the period between June and December 2012 – during Cyprian Presidency (*The debate related thereto was held at the 38th sitting of the Sejm*);
- concerning granting Kraków the role of the host of the Winter Olympic Games 2022 and the Winter Paralympic Games 2022;
- concerning changes within personal composition of the Sejm committees.

THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- amending the act on the agricultural tax (*The Senate's amendment was accepted*);
- amending the act on the local government employees and some related acts (*Some of the Senate's amendments were accepted*);
- amending the act on the system of common courts (*The Senate's amendments were accepted*);
- amending the Code of Civil Procedure (*Some of the Senate's amendments were accepted*);
- amending the act on vehicle drivers (*The Senate's amendment was accepted*).

THE SEJM REFERRED TO COMMITTEES

- Government bill amending the Code of Civil Procedure;
- Government bill amending the act on payment services and some related acts;
- Deputies' bill amending the Road Traffic Act and the Petty Offences Procedure Code;
- Deputies' bill amending the Road Traffic Act and some related acts;
- Deputies' bill amending the Road Traffic Act as well as amending some related acts;
- Deputies' bill amending the act on public roads and some related acts;
- Deputies' bill amending the act on personal income tax and the act on corporate income tax.

THE SEJM ACCEPTED the Report on the state of protection of the Polish language in the years 2010–2011 presented by the Council for the Polish Language.

THE SEJM CONSIDERED THE CURRENT INFORMATION on actions undertaken by the Council of Ministers aimed at retaining control by the State Treasury over the consolidated company of strategic importance for the State – Grupa Azoty SA with the headquarters in Tarnów, in relation to acquiring the package of 9.7% of stock in Grupa Azoty SA by the Russian company Acron and the declarations of further acquiring of stock by the Russian giant.

THE SEJM REJECTED IN THE SECOND READING the Deputies' bill amending the act on cemeteries and burying the dead.

THE SEJM REJECTED IN THE FIRST READING

- Deputies' bill on public supervision of applying the transaction prices;
- Deputies' bill amending the Tax Ordinance;
- Deputies' bill on the financial services tax.

THE SEJM REFERRED TO COMMITTEES

- Deputies' bill amending the Labour Code and the act social security money allowance in case of ailments and maternity;
- Deputies' bill amending the Labour Code and the act on the system of social insurance;
- Deputies' bill amending the Labour Code and some related acts;

- Government bill amending the Labour Code and some related acts.

WITH A MOMENT OF SILENCE, THE SEJM COMMEMORATED the 30th anniversary of the death of **Grzegorz Przemyk** – the victim of the martial law, who died as a result of battery by functionaries of Civic Militia and Motorized Reserves of the Citizens' Militia on 14 May 1983.
