65th SITTING OF THE SEJM, 2-4 APRIL 2014

THE SEJM PASSED THE ACTS

- on establishing and disbursing legal guardian allowances;
- amending the act on family benefits;
- on facilitating access to performance of some regulated occupations:
- amending the act on waste:
- amending the Water Law and some related acts;
- amending the Atomic Energy Law and some related acts:
- amending the act on retirement pensions of professional soldiers and their families and the act on retirement pensions of the officials of the Police, the Internal Security Agency, the Intelligence Agency, the Military Counterintelligence Service, the Military Intelligence Service, the Central Anticorruption Bureau, the Border Guard, the Government Protection Bureau, the State Fire Service, the Prison Service and their families;
- amending the Road Traffic Law.

THE SEJM ADOPTED RESOLUTIONS

- on the 600th anniversary of establishing Polish-Turkish diplomatic relations;
- honouring the memory of Józef Chełmoński;
- concerning grating the consent by the Sejm of the Republic of Poland to bring Deputy Krzysztof Borkowski to criminal accountability (The Sejm did not grant its consent to bring the Deputy to accountability);
- concerning changes within personal compositions of the Sejm committees;
- concerning the additional election of the personal composition of the Deputies' Ethics Committee.

THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

 amending the Petty Offences Procedure Code (Some of the Senate's amendments were accepted);

- on indemnity compensation for incurred casualties and illnesses related to service (The Senate's amendments were accepted);
- on European Citizens' Initiative (The Senate's amendment was accepted);
- amending the Penal Code and some related acts (The Senate's amendments were accepted).

THE SEJM ACCEPTED

- report on implementation of the Act of 26 October 1982 on education in sobriety and prevention of alcoholism in the period 1 January—31 December 2010, submitted by the Council of Ministers;
- report on the realisation of the Programme of Reducing the Health Consequences of Tobacco Smoking in Poland in 2012, submitted by the Council of Ministers;
- report on the realisation of tasks resulting from the National Mental Health Protection Programme in 2011, submitted by the Council of Ministers;
- report on the realisation of the Świnna Poręba Water Reservoir Construction Programme for 2006–2013 in 2012, submitted by the Minister of Environment.

THE SEJM CONSIDERED the report on the realisation of the National Domestic Violence Counteraction Programme between 1 January 2012 and 31 December 2012, submitted by the Council of Ministers (*The motion to reject the report shall be subject to a vote at the next sitting*).

THE SEJM CONSIDRED THE CURRENT INFOR- MATION considering activities undertaken by the government with the aim of including Polish citizens in the visa-free travel into the United States of America.

With a minute of silence, the Sejm honoured the memory of **Deputy Krystyna Poślednia** who died on 1 April 2014.
