

78th SITTING OF THE SEJM, 21–23 OCTOBER 2014

THE SEJM PASSED THE ACTS

- amending the act on the personal income tax and some related acts;
- amending the act on retirement pay and social benefits financed out of the Social Insurance Fund and some related acts;
- on facilitating the performance of business activity;
- amending the act on safety of food and nourishment;
- amending the act on the income of units of the territorial government;
- amending the act which itself amended the act on the corporate income tax, the act on the personal income tax and some related acts;
- amending the act on the system of social insurance and some related acts;
- amending the act on the system of the national producer registry, farm registry and motions on awarding payments registry;
- amending the act on the local referendum;
- amending the act on prevention of sea pollution by ships and some related acts;
- ratifying the Protocol between the Republic of Poland and the Kingdom of Belgium amending the Convention between the Republic of Poland and the Kingdom of Belgium for the avoidance of double taxation and prevention of income tax evasion with respect to taxes on income and fortune, signed in Warsaw on 20 August 2001, signed in Luxembourg on 14 April 2014.

THE SEJM ADOPTED RESOLUTIONS

- concerning changes within personal composition of the Sejm committees;
- concerning the election of a new personal composition of the European Union Affairs' Committee;
- concerning granting the consent by the Sejm of the Republic of Poland to bring Deputy Patryk Jaki to

criminal accountability (*the Sejm did not grant its consent*).

THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- on the reverse mortgage loan;
- amending the act on toll motorways and the National Road Fund, the act on the Railway Fund and the act on the excise duty.

THE SEJM RETURNED TO COMMITTEES the government bill annulling the act establishing the long-term "Programme for the Oder – 2006".

THE SEJM REFERRED TO A COMMITTEE the Deputies' bill amending the act on the excise duty.

THE SEJM CONSIDERED IN THE FIRST READING the Deputies' bill amending the Labour Code (*the motion to reject the bill shall be subject to a vote at the next sitting of the Sejm*).

THE SEJM ACCEPTED

- "Report on realization of the state ecological policy in the years 2009–2012 with a perspective until 2016," submitted by the Prime Minister;
- report on the realization of tasks resulting from the "Programme for the Oder – 2006" in the years 2012 and 2013, submitted by the Council of Ministers;
- report on the realization of the "Świnna Poręba water reservoir construction programme for 2006–2013" in 2013, submitted by the Minister of Environment.

THE SEJM CONSIDERED THE CURRENT INFORMATION concerning the science budget for 2015 and the changed principles for the distribution of statutory subsidy for financing scientific research.
