

92ND SITTING OF THE SEJM, 13–15 MAY 2015

THE SEJM PASSED THE ACTS

- amending the act on family benefits;
- amending the act on money allowance provided out of social insurance in case of ailments and maternity, and some related acts;
- amending the act on the operation of cooperative banks, their associations, and associating banks, and some related acts;
- on substances depleting the ozone layer and particular fluorinated greenhouse gases;
- amending the Electoral Code;
- amending the act on cemeteries and burying the dead, the act on graves and war cemeteries and the act on the Institute of National Remembrance – Commission for the Prosecution of Crimes against the Polish Nation;
- amending the act on construction products and the Construction Law;
- amending the act on real estate management;
- amending the act on fire safety measures;
- amending the act on particular solutions concerning the counteraction of the effects of flood and the act on supporting entrepreneurs affected by the effects of flood in 2010;
- amending the Copyright and Neighbouring Rights Act;
- amending the act on the commune government and some related acts;
- amending the Geodetic and Cartographic Law;
- amending the act on court fees in civil cases.

THE SEJM REFERRED TO COMMITTEES

- Government bill on free legal assistance, free legal information and the legal education of the society;
- Government bill amending the Accountancy Act and some related acts;
- Government bill amending the act on family benefits and some related acts;
- Government bill on the Military Property Agency;
- Government bill amending the act on maritime safety and some related acts;

- Committee bill amending the act on the Supreme Court.

THE SEJM RETURNED TO A COMMITTEE the Deputies' bills amending the act on restructurisation and technical modernisation, as well as financing of the Armed Forces of the Republic of Poland, and the Government's bill amending the act on restructurisation and technical modernisation, as well as financing of the Armed Forces of the Republic of Poland and the act on public finances.

THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- Restructuring Law (*some of the Senate's amendments were accepted*);
- amending the Petty Offences Procedure Code (*the Senate's amendment was accepted*);
- amending the act on agricultural chambers and some related acts (*the Senate's amendments were accepted*).

THE SEJM HEARD the report of the Minister of the Interior on the realization in 2014 of the act of 24 March 1920 on purchasing real estate property by foreigners (*the vote on the motion to reject the report shall be held at the next sitting of the Sejm*).

THE SEJM CONSIDERED THE CURRENT INFORMATION concerning the activities of the government for the protection of readership in Poland and the possibility of a wide access to books nationwide, with a particular consideration of areas outside large cities.

THE SEJM ADOPTED RESOLUTIONS

- honouring the memory of Marshal Józef Piłsudski on the 80th anniversary of his death;
- honouring the victims of Upper Silesian Tragedy of 1945;
- concerning changes within personal composition of the Sejm committees.
