

96TH SITTING OF THE SEJM, 7–10 JULY 2015

THE SEJM PASSED THE ACTS

- amending the Tax Ordinance and some related acts (*of the print no. 3462*);
- amending the Tax Ordinance and some related acts (*of the print no. 2605*);
- amending the act on financial market supervision and some related acts;
- on considering complaints by financial market entities and on the Financial Commissioner;
- amending the act on mortgage bonds and mortgage banks, and some related acts;
- amending the act on family benefits and some related acts;
- amending the act on social aid;
- amending the act on the personal income tax and the act on the corporate income tax;
- on inspection of particular investments;
- amending the act on the Railway Fund;
- amending the act on the protection of agricultural land and woodland;
- amending the act on managing land communities;
- amending the act on Agricultural Market Agency and organisation of specific agricultural markets, and some related acts;
- on supporting the sustainable development of the fishing sector with the participation of the European Maritime and Fisheries Fund;
- amending the act on the organisation of the fish market;
- on used electric and electronic equipment;
- amending the Law on the system of common courts and some related acts;
- on advisory teams of court experts;
- amending the Code of Penal Procedure;
- amending the Penal Execution Code;
- amending the Code of Civil Procedure, the Notary Law and some related acts;
- amending the Law on proceedings before administrative courts;
- amending the act on judicial enforcement officers and enforcement;
- amending the act on court probation officers;
- amending the act on the prosecution service, the act on the exercise of the mandate of a Deputy or Senator, the act on the personal data protection, the act on the Institute of National Remembrance – Commission for the Prosecution of Crimes against the Polish Nation and the act on the Commissioner for Children’s Rights and the Law on the system of common courts;
- amending the Road Traffic Law and some related acts;

- amending the Road Traffic Law;
- amending the act on public benefit and volunteer work and the act on foundations;
- amending the Copyright and Neighbouring Rights Act and the act on gambling games;
- amending the act on the safety of mass events and some related acts;
- on the Military Property Agency;
- amending the act on the Commissioner for Children’s Rights;
- amending the act on the Border Guard and some related acts;
- amending the act on providing protection to foreigners on the territory of the Republic of Poland and some related acts;
- amending the act on annulling court decisions concerning persons persecuted on grounds of their involvement in the interest of independence of the Polish State;
- establishing the Remembrance Day of the Victims of the Augustów Roundup in July 1945;
- amending the act on the Polish Air Navigation Services Agency;
- amending the Electoral Code.

THE SEJM CONSIDERED THE SENATE’S RESOLUTIONS CONCERNING THE ACTS

- on tax administration (*some of the Senate’s amendments were accepted*);
- amending the Civil Code, the Code of Civil Procedure and some related acts (*the Senate’s amendments were accepted*);
- amending the act on monument protection and care and the act on museums (*the Senate’s amendments were accepted*);
- amending the act on reconstruction, technical modernisation and financing of the Armed Forces of the Republic of Poland and the act on public finances (*some of the Senate’s amendments were accepted*).

THE SEJM HELD A SECOND READING OF the Deputies’ bill amending the act on public finances (*the third reading of the bill shall be held at the next sitting of the Sejm*).

THE SEJM RETURNED TO COMMITTEES

- Deputies’ bill on particular principles for preparation and realisation of strategic investments in the scope of transmission networks;
- Citizens’ bill amending the act on retirement pay and social benefits financed out of Social Insurance

Fund *(the Sejm did not accept the motion to reject the bill)*;

- Deputies' bill amending the act on retirement pay and social benefits financed out of Social Insurance Fund and some related acts *(the Sejm did not accept the motion to reject the bill)*;
- Deputies' bill amending the act on family benefits *(of print no. 1297; the Sejm did not accept the motion to reject the bill)*.

THE SEJM REFERRED TO COMMITTEES

- Senate's bill amending the act on local taxes and fees;
- government bill on revitalisation;

THE SEJM ADOPTED RESOLUTIONS

- concerning the report of the National Broadcasting Council on its activity in 2014 *(the Sejm did not accept the amendment rejecting the report)*;
- concerning changes within personal composition of the Sejm committees.

THE SEJM REJECTED IN THE SECOND READING

- Deputies' bill amending the act on retirement pay and social benefits financed out of Social Insurance Fund *(of the print no. 136)*;
- Deputies' bill amending the act on family benefits *(of the print no. 323)*.

THE SEJM HEARD the information of the President of the Constitutional Tribunal on relevant problems resulting from the activity and jurisprudence of the Constitutional Tribunal in 2014.

THE SEJM WAS PRESENTED WITH THE CURRENT INFORMATION concerning the domination of the foreign capital in the scope of public procurement as of the information of the Public Procurement Office in 2014.

WITH A MINUTE OF SILENCE, THE SEJM HONOURED the memory of persons murdered in the Eastern borderland in 1943.
