

16th sitting of the Sejm, 13–15 JUNE 2012

THE SEJM PASSED THE ACTS

- amending the act on therapeutic activity and some related acts;
- amending the act on preventing and combating infections and contagious human diseases and the act on the State Sanitary Inspection;
- amending the Code of Penal Procedure;
- ratifying the Convention on the Rights of Persons with Disabilities, drawn up in New York on 13 December 2006.

THE SEJM ADOPTED RESOLUTIONS

- honouring the memory of Andrzej Frycz Modrzewski;
- concerning participation of the Republic of Poland in the works of the European Union in the period between July and December 2011 (during Polish Presidency).

THE SEJM CONSIDERED THE SENATE'S RESOLUTION CONCERNING THE ACT

- on the effects of entrusting labour to foreign persons illegally residing in the territory of the Republic of Poland (The Senate's amendments were accepted).

THE SEJM REFERRED TO THE COMMITTEE the Government bill amending the Maritime Code and the act on maritime areas of the Republic of Poland and on maritime administration.

THE SEJM ACCEPTED

- report on the realisation of EURO 2012 undertakings and tasks realised as regards Poland's preparation for the European Football Championship UEFA EURO 2012 Final Tournament (March 2011–January 2012) submitted by the Council of Ministers (The Sejm rejected the motion to reject the document, submitted at the 15th sitting);
- National Spatial Development Concept 2030 submitted by the Prime Minister (The Sejm rejected the motion to reject the document, submitted at the 15th sitting);
- report of the Minister of the Interior on the realisation in 2011 of the act of 24 March 1920 on purchasing real estate property by foreigners.

THE SEJM CONSIDERED the information of the Minister of Transport, Construction and Maritime Economy on the realisation of the act on the establishment of the long-term "Seashore protection programme" in 2011 (The motion to reject the information, submitted during the debate, shall be subject to a vote at the next sitting).

THE SEJM CONSIDERED THE CURRENT INFORMATION on the state of health care, particularly as regards the situation involving the introduction of medicinal programmes and the protest of health care practitioners.

THE SEJM REJECTED IN THE FIRST READING

- Deputies' bill amending the act on the commune government and some related acts;
- Deputies' bill on the income tax;
- Deputies' bill – Introductory provisions to the act on the income tax;
- Deputies' bill amending the act on the excise duty.

THE SEJM REJECTED IN THE SECOND READING

- Deputies' bills amending the act on the taking over by the State of the mortmain estate, bestowing agricultural farms upon parsons and establishing the Church Fund and some related acts (prints no. 255, 256);
- Deputies' bill annulling the regulation of the Minister of National Education of 23 December 2008 on the kindergarten core curriculum and the general education programme in individual types of schools (Journal of Laws 2009, no. 4, item 17), as well as the regulation of the Minister of National Education on framework education programmes in public schools of 7 February 2012;
- Deputies' draft resolution summoning the Government of the Republic of Poland to amend the resolution of the Minister of National Education of 7 February 2012 on framework education programmes in public schools (Journal of Laws 2012, 204).

THE SEJM DID NOT ACCEPT the Deputies' motion to hold a national referendum on the renegotiation of the energy and climate package.
