

19th sitting of the Sejm, 24–27 JULY 2012

THE SEJM PASSED THE ACT accepting the report on the implementation of the Budget Act in the period from 1 January until 31 December 2011 and granting the approval of the financial accounts submitted by the Council of Ministers.

In the resolution, the Sejm granted the Council of Ministers the approval of financial accounts in the period from 1 January until 31 December 2011.

Furthermore, the Sejm accepted the information on warranties and guarantees granted in 2011 by the State Treasury, particular legal persons and the National Household Bank (Bank Gospodarstwa Krajowego), submitted by the Prime Minister. The Sejm was also presented with the report on the activity of the National Bank of Poland in 2011.

THE SEJM PASSED THE ACTS

- amending the act on the system of education and the act which itself amended the act on the system of education and some related acts;
- amending the act on the system of educational information and some related acts;
- amending the act on health care benefits provided out of public funds;
- amending the act on public roads;
- amending the act on the preparation of the European Football Championship UEFA EURO 2012 Final Tournament;
- amending the act on housing cooperatives;
- amending the Press Law;
- amending the Code of Penal Procedure;
- amending the Maritime Code and the act on maritime areas of the Republic of Poland and on maritime administration;
- on the State Commission for the Investigation of Marine Accidents;
- amending the Customs Law;
- on renaming the Kazimierz Pułaski Technical University in Radom as the Kazimierz Pułaski University of Technology and Life Sciences in Radom.

THE SEJM REFERRED TO COMMITTEES

- Government bill amending the act on the personal income tax;
- Deputies' bill amending the Penal Code;
- Deputies' bill amending the Penal Code and the Code of Penal Procedure.

THE SEJM ACCEPTED

- report on the activity of the Supreme Audit Office in 2011;
- "Information on the realisation of the act on special economic zones – the state as of 31 December 2011" submitted by the Council of Ministers.

THE SEJM WAS PRESENTED WITH

- information on relevant problems resulting from the activity and jurisprudence of the Constitutional Tribunal in 2011;
- information on the activity of the Supreme Court in 2011.

THE SEJM CONSIDERED THE CURRENT

INFORMATION concerning the plans for erecting a nuclear power plant in Poland.

THE SEJM CONSIDERED IN THE FIRST

READING the Deputies' bill amending the Energy Law and some related acts. *(The bill was withdrawn by its sponsors.)*
