

38th sitting of the Sejm, 17–19 APRIL 2013

THE SEJM PASSED THE ACTS

- amending the acts regulating the practicing of particular professions;
- amending the Banking Law and the act on investment funds;
- on the means of physical coercion and firearms;
- amending the act on principles for conducting the development policy;
- amending the act on vehicle drivers and some related acts;
- amending the act on retirement pay and social benefits financed out of Social Insurance Fund;
- amending the act on the medical chambers and some related acts.

THE SEJM ADOPTED RESOLUTIONS

- commemorating the 70th anniversary of the outbreak of the Warsaw Ghetto Uprising;
- commemorating the 140th anniversary of the birth of Wojciech Korfanty;
- concerning changes within personal composition of the Sejm committees;
- concerning the election of the new personal composition of the European Union Affairs' Committee.

THE SEJM CONSIDERED THE SENATE'S RESOLUTION CONCERNING THE ACT

amending the act on corporate savings and loan associations and some related acts (*The Senate's amendments were accepted*).

THE SEJM REFERRED TO COMMITTEES

- Citizens' bill on family allotment gardens (of print no. 1204);
- Deputies' bills on allotment gardens (of prints no. 1148 and 1240);
- Deputies' bill amending the act on family allotment gardens, the act on agricultural tax and the act on local taxes and charges (of print no. 1170);

- Government bill amending the act on the office of the Minister of National Defence and some related acts;
- Deputies' bill amending the act on communal economy, the act on the voivodship government and the act on the district government;
- Deputies' bill on disciplinary proceedings against persons performing particular legal professions.

THE SEJM ACCEPTED

- information submitted by the Prime Minister on the situation in Fiat Auto Poland and Polish automotive industry;
- report of the Council of Ministers on the realisation of the National Domestic Violence Counteraction Programme between 1 January 2011 and 31 December 2011 (*The motion to reject the report was submitted at the 37th sitting of the Sejm*).

THE SEJM CONSIDERED

the information concerning participation of the Republic of Poland in the works of the European Union in the period between July and December 2012 (during Cyprian Presidency) (Consideration of information shall be completed at the next sitting of the Sejm).

THE SEJM CONSIDERED THE CURRENT INFORMATION

on the situation of the elderly and their families, particularly of not self-reliant persons, requiring constant aid, as well as the evaluation of state aid actions undertaken for the benefit of this part of the society.

THE SEJM REJECTED IN THE FIRST READING

- Deputies' bill amending the Penal Code (*The debate on the bill was held at the 37th sitting of the Sejm*).
- Deputies' bill on particular principles for settling the accounts with subcontractors of Dolnośląskie Surowce Skalne JSC as regards the construction of the A2 motorway and subcontractors of Poldim JSC as regards the construction of the A4 motorway.
