

## 56<sup>th</sup> SITTING OF THE SEJM, 11–13 DECEMBER 2013

### THE SEJM PASSED THE ACTS

- amending the Labour Code;
- amending the act on public benefit and volunteer work and some related acts;
- amending the act on realizing the right to compensation on the grounds of abandoning real estate outside the present-day borders of the Republic of Poland;
- amending the Law on the System of Military Courts;
- amending the Hunting Law;
- ratifying the Implementing Protocol between the Government of the Republic of Poland and the Government of the Republic of Moldova to the Agreement between the European Community and the Republic of Moldova on the Readmission of Persons Residing Without Authorisation, drawn up in Brussels on 10 October 2007, signed in Matrahaza on 11 October 2012;
- ratifying the Protocol on the Privileges and Immunities of the European Organisation for the Exploitation of Meteorological Satellites (EUMETSAT), drawn up in Darmstadt on 1 December 1986.

**THE SEJM ADOPTED THE RESOLUTION** honouring the memory of Włodzimierz Przerwa-Tetmajer on the 90<sup>th</sup> anniversary of His death.

### THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- amending the act on mortgage register and mortgage (*the Senate's amendments were accepted*);

- on aliens (*some of the Senate's amendments were accepted*);
- amending the act on the income of units of territorial government (*a vote on the resolution of the Senate was postponed to the next sitting of the Sejm*);
- on family allotment gardens (*a vote on the resolution of the Senate was postponed to the next sitting of the Sejm*).

### THE SEJM RETURNED TO COMMITTEES

- Government draft budget for 2014;
- Government bill on calculating and disbursing retirement pay, the right to which was suspended in the period between 1 October 2011 and 21 November 2012;
- Senate's bill amending the act on public finances and some related acts.

**THE SEJM REFERRED TO THE COMMITTEE** the Government bill amending the Electoral Code.

**THE SEJM ACCEPTED** the information of the Minister of Foreign Affairs as regards the course and results of the Eastern Partnership Summit in Vilnius on 28–29 November 2013.

**THE SEJM CONSIDERED THE CURRENT INFORMATION** on the unsolved problem of administrative penalties inflicted on fishermen due to cod fishing in 2007.

## 57<sup>th</sup> SITTING OF THE SEJM, 13 DECEMBER 2013

### THE SEJM PASSED THE ACTS

- Budget Act for 2014;
- on calculating and disbursing retirement pay, the right to which was suspended in the period between 1 October 2011 and 21 November 2012.

### THE SEJM ADOPTED RESOLUTIONS

- commemorating the 32<sup>nd</sup> anniversary of introduction of the Martial Law;

- on the 95<sup>th</sup> anniversary of the outbreak of the Greater Poland Uprising.

### THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- amending the act on the income of units of the territorial government (*the Senate's amendments were accepted*);
- on family allotment gardens (*the Senate's amendments were accepted*).
