

87TH SITTING OF THE SEJM, 18–20 FEBRUARY 2015

THE SEJM PASSED THE ACTS

- on supporting the development of rural areas with the contribution of the European Agricultural Fund for Rural Development as a part of the Rural Development Programme for the years 2014–2020;
- on local development with the participation of local community;
- amending the act on animal health protection and combating contagious animal diseases;
- amending the act on judicial enforcement officers and enforcement;
- amending the Law on proceedings before administrative courts;
- amending the act on the goods and services tax and the Public Procurement Law;
- amending the act on the National School of the Judiciary and Prosecution Service and some related acts;
- ratifying the Agreement between the Government of the Republic of Poland and the Government of the Republic of Serbia on cooperation in combating organized crime and any other crime, signed in Warsaw on 7 November 2011;
- ratifying the Agreement between the Republic of Poland and the Republic of Peru on the transfer of convicted persons, signed in Lima on 27 May 2014.

THE SEJM ADOPTED RESOLUTIONS

- concerning changes within the composition of Sejm secretaries;
- concerning changes within personal composition of the Sejm committees.

THE SEJM CONSIDERED THE SENATE'S RESOLUTIONS CONCERNING THE ACTS

- amending the Law on the system of common courts and some related acts (*some of the Senate's amendments were accepted*);
- amending the Penal Code and some related acts (*some of the Senate's amendments were accepted*);
- amending the Construction Law and some related acts (*some of the Senate's amendments were accepted*);
- amending the act on the system of education and some related acts (*the Senate's amendments were accepted*);
- amending the act on road transport and some related acts (*the Senate's amendments were accepted*);

- on found property (*some of the Senate's amendments were accepted*);
- on renewable sources of energy (*some of the Senate's amendments were accepted*).

THE SEJM REFERRED TO COMMITTEES

- Government bill on substances depleting the ozone layer and on some fluorinated greenhouse gases;
- Senate's bill amending the Family and Guardianship Code;
- Senate's bill amending the Family and Guardianship Code and the Code of Civil Procedure;
- Senate's bill amending the Petty Offences Procedure Code and the act which itself amended the Code of Penal Procedure, and some related acts.

THE SEJM REJECTED IN THE FIRST READING

the Deputies' bill amending the act on the personal income tax.

THE SEJM ACCEPTED the report of the Council of Ministers on the realization of tasks resulting from the National Drug Use Prevention Programme in 2013.

THE SEJM CONSIDERED the reports of the Council of Ministers on the public aid in Poland, provided to entrepreneurs in the years 2011–2013 (*the motion to reject the reports shall be subject to a vote at the next sitting of the Sejm*).

THE SEJM CONSIDERED THE CURRENT INFORMATION concerning no reaction of the chief organs of the state as regards the revealed anomalies in privatizing "Ciech" JSC and the information on a possible tax avoidance via investing the money in HSBC Private Bank.
