

101ST SITTING OF THE SEJM, 23–25 SEPTEMBER 2015

THE SEJM PASSED THE ACTS

- amending particular acts as regards supporting innovation;
- amending the act on employment promotion and institutions of the labour market;
- amending the act on professional and social rehabilitation, as well as on the employment of the disabled persons;
- amending the act on the information system in health care and some related acts;
- amending the act on health care benefits financed out of public funds and some related acts;
- on financing specific health care benefits in the years 2015–2018;
- amending the act on the National Emergency Medical Services, the act on therapeutical activity and the act amending the act on therapeutical activity and some related acts;
- on supporting housing credit beneficiaries in a difficult financial situation;
- amending the Banking Law and some related acts;
- amending the act on payment services;
- amending the act on the freedom of business activity and some related acts;
- amending the act on craft;
- amending the act on compulsory insurance, the Insurance Guarantee Fund and the Polish Motor Insurers' Bureau;
- amending the act on forests;
- on metropolitan unions;
- amending the act on the income of the units of territorial government;
- amending the act on spatial planning and order;
- amending the act on protection of agricultural land and woodland;
- amending the act on financial support for the establishment of social housing, sheltered housing, dormitories and homes for the homeless;
- amending the Law on Assemblies and some related acts;
- on the profession of a physical therapist;
- amending the Pharmaceutical Law;
- amending the act on therapeutic activity;
- amending the act on railway transport;
- amending the act on establishing the long-term "Seashore protection programme";
- amending the act on national and ethnic minorities and on the regional language, as well as amending some related acts;
- amending the Road Traffic Law;
- on implementation of the Agreement between the Government of the Republic of Poland and the Government of the United States of America to Improve International Tax Compliance and to Implement FATCA;
- ratifying the Execution Agreement between the Government of the Republic of Poland and the Government of the United States of America to the Agreement between the Government of the Republic of Poland and the Government of the United States

of America Concerning the Deployment of Ground-Based Ballistic Missile Defence Interceptors in the Territory of the Republic of Poland, Concerning the Use of the Territories and Air Space around the Base of the Ballistic Missile Defence System, signed in Warsaw on 27 April 2015.

THE SEJM REFERRED TO A COMMITTEE a Deputies' bill amending the act on safety of food and nourishment and some related acts.

THE SEJM HEARD the "Information on the activity of administrative courts in 2014" submitted by the President of the Supreme Administrative Court.

THE SEJM ACCEPTED

- information of the Prime Minister on the migration crisis in Europe and its repercussions for Poland (*the Sejm did not accept the motion to reject the information, submitted at the 100th sitting*);
- information of the Minister of Infrastructure and Development on the realisation of tasks resulting from the act of 28 March 2003 establishing the long-term "Seashore protection programme" in 2014 (*the Sejm did not accept the motion to reject the information, submitted at the 99th sitting*);
- report of the Chief Labour Inspector on the activity of the National Labour Inspectorate in 2014.

THE SEJM HEARD THE GOVERNMENT'S CURRENT INFORMATION concerning the Government's plans as regards the aid for the elderly persons, the functioning of the retirement system and its financing.

THE SEJM ACCEPTED the report of the special subcommittee for the realization of acts on co-operative savings and credit unions along with the opinions of the Minister of Finances and the Polish Financial Supervision Authority, submitted by the Public Finances Committee (*the Sejm did not accept the motion to reject the report*).

THE SEJM ADOPTED RESOLUTIONS

- establishing 2 of October the Remembrance Day of the Civil Population of the Insurgent Warsaw;
- concerning the election of the new personal composition of the European Union Affairs Committee;
- concerning changes within personal composition of the Sejm committees.

THE SEJM DECIDED the former Minister of Justice and Prosecutor General Zbigniew Ziobro shall not be held accountable before the Tribunal of State (*on the basis of Article 13 para. 3 of the act on the Tribunal of State, Marshal of the Sejm declared the proceedings in the case discontinued*).
